**GAMBARAN PENGETAHUAN DAN SIKAP KELUARGA TENTANG
PERAWATAN PASIEN POST OPERASI KATARAK
(LITERATURE REVIEW)**

ABSTRAK

Penelitian ini di latarbelakangi oleh tingginya penyebab gangguan penglihatan di dunia sekitar (25,81%) diakibatkan oleh katarak. Penelitian ini bertujuan untuk mengetahui gambaran pengetahuan dan sikap keluarga tentang perawatan pasien post operasi katarak. Metode penelitian yang digunakan yaitu metode deskriptif dengan desain literature review, dengan teknik pengambilan data sekunder dari jurnal yang didapatkan melalui google scholar, kemudian setelah melalui proses skrining dengan metode PRISMA flow didapatkan 3 jurnal yang sesuai dengan tujuan penelitian. Hasil literature review didapatkan bahwa tingkat pengetahuan keluarga tentang perawatan pasien post operasi katarak pada 1 jurnal menunjukkan kategori baik dengan persentase (85,7%) dan pada 2 jurnal menunjukkan kategori kurang dengan rentang persentase (54,1%)-(76,2%). Hasil dari sikap keluarga tentang perawatan pasien post operasi katarak pada 2 jurnal menunjukkan kategori positif dengan rentang persentase (85,7%)-(86,4%) dan 1 jurnal menunjukkan kategori negatif dengan persentase (50,7%). Kesimpulan pengetahuan keluarga tentang perawatan pasien post operasi katarak dalam kategori kurang dan sikap keluarga tentang perawatan post operasi katarak dalam kategori positif. Berdasarkan hasil penelitian dengan metode literature review ini disarankan bagi profesi keperawatan agar meningkatkan mutu kualitas pelayanan keperawatan dalam memberikan promosi kesehatan kepada keluarga pasien yang menjalani perawatan post operasi katarak.

**THE DESCRIPTION OF KNOWLEDGE AND ATTITUDE FAMILY ABOUT
CARE OF PATIENTS POST CATARACT SURGERY
(LITERATURE REVIEW)**

This research is motivated by the high causes of visual impairment in the world around (25.81%) caused by cataracts. The research method used is descriptive method with a literature review design. The data used in this study is secondary data, namely research results journals in journals searched through Google Scholar search sites then after going through the screening process with the frisma flow method, 3 journals were obtained that were in accordance with the research objectives. The results of the literature review found that the level of family knowledge about post cataract surgery patient care in 1 journal showed a good category with a percentage of 85.7% and in 2 journals it showed a less category with a percentage range of 54.1%-76.2%. The results of the family's attitude about the care of post cataract surgery patients in 2 journals showed a positive category with a percentage range of 85.7%-86.4% and 1 journal showed a negative category with a percentage of 50.7%.Conclusion: family knowledge about post cataract surgery patient care is in the poor category and family attitudes about post cataract surgery care are in the positive category. Based on the results of this study using the literature review method, it is recommended for the nursing profession to improve the quality of nursing services in providing health promotion to the families of patients undergoing post cataract surgery care.
