**ABSTRAK**

Pada tahun 2017 Angka Kematian Neonatal (AKN) di Indonesia sebesar 15 per 1.000 kelahiran hidup. AKN ini masih tinggi dan pada tahun 2024 diharapkan menjadi 10 per 1000 kelahiran hidup.(1) Beberapa upaya kesehatan dilakukan untuk menurunkan AKN salah satunya yaitu menjamin tersedianya pelayanan kesehatan sesuai standar pada kunjungan neonatal. Bidan diharapkan mampu mendukung usaha peningkatan derajat kesehatan neonatus, yakni melalui peningkatan kualitas pelayanan neonatal. Tujuan penulisan tugas akhir ini adalah melakukan asuhan kebidanan pada By. Ny. N Neonatus Cukup Bulan Sesuai Masa Kehamilan di Praktik Mandiri Bidan S Kabupaten Bogor.

Metode penulisan laporan tugas akhir ini adalah metode laporan kasus dengan menggunakan aplikasi manajemen kebidanan dan pendokumentasian dalam bentuk SOAP. Teknik pengumpulan data yaitu dengan menggunakan metode wawancara, pemeriksaan fisik, observasi, studi dokumentasi, dan studi litelatur.

Dari data subjektif didapatkan By. Ny. N lahir pada tanggal 13 April 2021 pukul 14.30 WIB, perempuan, dibantu oleh paraji. Data objektif menunjukkan keadaan umum baik, berat badan 2900 gram, panjang badan 49 cm, lingkaran kepala 33 cm dan lingkaran dada 32 cm. Tanda-tanda vital dalam batas normal. Penilaian dengan Ballard score didapatkan skor 35 (usia kehamilan saat lahir  $\pm$ 38 minggu). Berdasarkan data subjektif dan objektif maka didapatkan diagnosa By. Ny. N Neonatus Cukup Bulan Sesuai Masa Kehamilan dalam keadaan baik. Penatalaksanaan asuhan sesuai dengan pelayanan neonatal esensial yaitu memberikan imunisasi Hepatitis B, pemeriksaan fisik bayi baru lahir, dan pemantauan tanda bahaya. Asuhan lain yang diberikan yaitu memberikan KIE mengenai perawatan bayi baru lahir, ASI eksklusif, tanda bahaya pada bayi baru lahir, imunisasi, pola asuh dan tumbuh kembang.

Asuhan dilakukan dari usia bayi 18 jam hingga 2 minggu, setelah dilakukan asuhan keadaan bayi baik dan ibu mengetahui perawatan bayi baru lahir. Saran untuk Ny. N agar mampu melakukan perawatan bayi secara mandiri, memahami pola asuh anak, tumbuh kembang anak, dan memberikan ASI Eksklusif.

**ABSTRACT**

*In 2017 The Neonatal Mortality Rate (NMR) in Indonesia is 15/1,000 live births. The NMR is still high and by 2024 expected to be 10/1000 live births. Several health efforts were made to reduce the neonatal mortality rate, one of which was to ensure the availability of standard health services at newborn visits. Midwives are expected to be able to support efforts to improve the health status of neonates, namely through improving the quality of neonatal services. The purpose of writing this final project is to provide midwifery care to baby Mrs. N Neonates at term according to gestation period in the Independent Practice of Midwife S, Bogor Regency.*

*The method of writing this final report is a case report method using midwifery management applications and documentation in the form of SOAP. Data collection techniques are by using interviews, physical examination, observation, documentation studies, and literature studies.*

*From subjective data obtained baby Mrs. N was born on April 13, 2021 at 02.30 p.m, assisted by a traditional birth attendant. Objective data showed that the general condition of the baby was good, weight 2900 grams, body length 49 cm, head circumference 33 cm and chest circumference 32 cm. Vital signs within normal limits. Based on the results of the assessment with the Ballard score obtained a score of 35 (gestational age at birth  $\pm$  38 weeks). Based on subjective and objective data, the diagnosis baby Mrs. N Neonates at term according to gestation period in good condition. The management of care is in accordance with essential neonatal services, namely providing Hepatitis B immunization, physical examination of newborns, and monitoring of danger signs. Other care provided is providing IEC regarding newborn care, exclusive breastfeeding, danger signs for newborns, immunization, parenting, growth and development.*

*Upbringing made from infant age to 18 hours to 2 weeks, after the baby's condition good upbringing and the mother knows newborn care. The care is carried out from the age of 18 hours to 2 weeks according to the baby's needs, there is no gap between theory and practice. Advice for Mrs. N to be able to care for babies independently, understand child care patterns, and provide exclusive breastfeeding.*
